The Board is the governing body of St John WA and is accountable to members and stakeholders. It has four distinct roles:

- Role 1: GCEO oversight and resourcing
- ▶ Role 2: Oversight of performance and accountability
- ▶ Role 3: Oversight of compliance and risk
- ► Role 4: Set strategic direction

In performing its duties, the Board follows the Corporations Act 2001 (Cth), St John WA Constitution, the AICD Governance Principles, and the Australian Charities and Not-for-Profits Commission's Governance Standards.

Strategy Day Highlights



The Board met on 27 November 2025, for its annual Strategy Session. I extend my appreciation to management for their substantive contributions to the Day.

Over the course of a full day, the Board and management conducted a "look back" and St John WA's execution of our strategy to date, conducted a detailed situation analysis of the key challenges and opportunities to consider, a "look forward" to 2030 of key initiatives to consider across strategic pillars and our financial roadmap.

The Strategy Day confirmed that St John WA has a clear strategic direction and that the work ahead now centres on disciplined, enterprise-wide execution. The discussions reinforced the importance of aligning systems, capability and investment to drive reliable performance across all services. The Board will continue to apply strong governance oversight, ensure decisions are grounded

in data and long-term sustainability, and maintain a focus on delivering consistent, measurable outcomes for the community.

The Board valued the contribution of all participants at the Strategy Day. In particular, it was beneficial to have Melanie Gates join her first full strategic discussion as a Director. Melanie brought a considered and technically strong perspective, drawing on her extensive knowledge and complemented the deep skills and experience of our existing directors.

Board Meeting Highlights

Following the Strategy Session, the Board held a Board meeting to address time sensitive approvals.

The meeting commenced with the Board acknowledging the Whadjuk people of the Noongar nation as the Traditional Custodians of the land where the meeting was being held and paid respects to Elders past, present and emerging.
